Plainview Public Schools Board of Education Meeting Monday, December 9, 2019

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 7:00 p.m. by Mike Sauser, President, on Monday, December 9, 2019. Frahm moved, Thor seconded to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Sauser, Krista Hanks, Tim Rasmussen, Wyatt Frahm, Jim Thor and Trenton Tarr.

CONSENT ITEMS

Consent items included the minutes of the November 11, 2019 regular meeting, the financial reports, and the December claims. The financial report (with last month's figures in parentheses) showed a balance of \$569,917.06 (\$924,539.56) in the General Fund. CDs total \$1,000,000.00 (1,000,000.00), Special Building Fund \$787,610.03 (\$794,401.12), Petty Cash \$2,496.85 (\$2,035.61), Activity Account \$133,548.87 (\$115,917.12), Lunch Account \$20,589.10 (\$19,907.82), Employee Benefit Fund \$51,976.54 (\$51,933.42), Depreciation Fund \$113,046.07 (\$112,943.77), Payroll Account \$2,681.43 (\$2,364.91), Custodial/Section 125 Account \$21,344.39 (\$21,515.09). Total assets were \$2,575,827.11 compared to \$2,975,137.90 a month ago, and \$2,827,459.06 a year ago. November receipts totaled \$57,538.36. That compares to \$434,050.54 in October. Disbursements totaled \$412,160.86 including \$70,420.47 for claims and \$341,740.39 for payroll. Building Fund receipts totaled \$4,892.91. Building Fund expenditures were \$11,684.00. Claims to the General Fund totaled \$127,383.18. Hanks moved, Rasmussen seconded, to approve the consent items. Upon roll call vote, the ayes were unanimous. Motion carried.

Frahm moved, Sauser seconded to accept the Plainview Public Schools Annual Report for 2019. Upon roll call vote, the ayes were unanimous. Motion carried.
