Plainview Public Schools Board of Education Meeting Monday, October 9, 2023

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 7:00 p.m. by Tim Rasmussen, President, on Monday, October 9, 2023. Sauser moved, Anderson seconded to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Rasmussen, Mike Sauser, Melissa Doerr, Wyatt Frahm, Deb Jensen, and Chance Anderson.

Rasmussen moved, Doerr seconded to approve the agenda. Upon roll call vote, the ayes were unanimous. Motion carried.

CONSENT ITEMS

Consent items included the minutes of the September 11, 2023 regular meeting, the September 18, 2023 special meeting, the financial reports, and the October claims. The financial report (with last month's figures in parentheses) showed a balance of \$992,573.14 (\$502,316.93) in the General Fund. CDs total \$600,000.00 (600,000.00), Special Building Fund \$103,149.06 (\$53,365.07), Petty Cash \$2,466.22 (\$676.08), Activity Account \$118,256.19 (\$148,646.52), Nutrition Account \$45,202.93 (\$55,301.77), Employee Benefit Fund \$53,128.85 (\$53,055.50), Depreciation Fund \$156,961.21 (\$56,870.99), Payroll Account \$3,669.54 (\$2,668.96), Custodial/Section 125 Account \$21,262.07 (\$9,928.75). Total assets were \$1,974,208.13 compared to \$1,411,945.06 a month ago, and \$2,009,982.61 a year ago. September receipts totaled \$1,291,025.62 compared to \$56,869.67 in August. Disbursements totaled \$800,769.41 including \$70,885.51 for claims, \$400,191.53 for payroll, \$100,000.00 transfer to Depreciation fund, \$222,000.00 transfer to Building fund and \$3,901.87 transfer to Nutrition fund and Summerland HS claim of \$3,790.50. Building Fund receipts totaled \$323,572.50. Building Fund expenditures were \$273,788.51. Claims to the General Fund totaled \$122,461.08. Sauser moved, Anderson seconded, to approve the consent items. Upon roll call vote, the ayes were unanimous. Motion carried.
