# Plainview Public Schools Board of Education Meeting Monday, February 12, 2024

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 7:00 p.m. by Tim Rasmussen, President, on Monday, February 12, 2024. Frahm moved, Sauser seconded to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Rasmussen, Wyatt Frahm, Deb Jensen, Mike Sauser, Melissa Doerr and Chance Anderson.

Anderson moved, Frahm seconded to approve the agenda. Upon roll call vote, the ayes were unanimous. Motion carried.

#### **CONSENT ITEMS**

Consent items included the minutes of the January 15, 2024 regular meeting and the February 2, 2024 Emergency meeting, the financial reports, and the February claims. The financial report (with last month's figures in parentheses) showed a balance of \$818,773.62 (\$104,106.98) in the General Fund. CDs total \$600,000.00 (600,000.00), Special Building Fund \$189,858.48 (\$117,107.73), Petty Cash \$2,500.44 (\$1,160.36), Activity Account \$125,693.96 (\$117,421.31), Nutrition Account \$26,322.43 (\$29,173.56), Employee Benefit Fund \$53,443.61 (\$53,359.67), Depreciation Fund \$73,030.62 (\$72,915.91), Payroll Account \$9,865.64 (\$8,722.78), Custodial/Section 125 Account \$20,487.07 (\$18,700.74). Total assets were \$1,812,250.02 compared to \$1,033,797.16 a month ago, and \$1,751,683.35 a year ago. January receipts totaled \$1,232,358.67 compared to \$284,522.56 in December. Disbursements totaled \$517,692.03 including \$88,871.88 for claims and \$428,820.15 for payroll. Building Fund receipts totaled \$80,300.75. Building fund expenditures were \$7,550.00. Claims to the General Fund totaled \$107,725.85. Sauser moved, Doerr seconded, to approve the consent items. Upon roll call vote, the ayes were unanimous. Motion carried.

Jensen moved, Sauser seconded to approve the membership in NASB for the 2024-2025 school year. Upon roll call vote, the ayes were unanimous. Motion carried.

### ACTION ON OFFERING A 1.0 F.T.E. TEACHING CONTRACT TO JOHN TORREY

Sauser moved, Frahm seconded to offer a certified teaching contract to Mr. John Torrey for the 2024-2025 school year. Upon roll call vote, the ayes were Rasmussen, Frahm, Sauser and Jensen. Nayes: Anderson and Doerr. Motion carried 4-2.
