Plainview Public Schools Board of Education Meeting Tuesday, June 18, 2019

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 7:07 p.m. by Mike Sauser, President, on Tuesday, June 18, 2019. Hanks moved, Rasmussen seconded to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Sauser, Krista Hanks, Tim Rasmussen, and Trenton Tarr. Wyatt Frahm and Jim Thor were absent.

CONSENT ITEMS

Consent items included the minutes of the May 13, 2019 regular meeting and the May 21, 2019 special meeting, the financial reports, and the June claims. The financial report (with last month's figures in parentheses) showed a balance of \$946,042.93 (\$277,347.95) in the General Fund. CDs total \$1,000,000.00 (1,000,000.00), Special Building Fund \$1,100,138.25 (\$936,525.50), Petty Cash \$2,979.78 (\$2,964.55), Activity Account \$92,831.29 (\$106,356.14), Lunch Account \$17,494.42 (\$20,029.77), Employee Benefit Fund \$51,614.71 (\$51,540.73), Depreciation Fund \$112,182.08 (\$112,007.99), Payroll Account \$3,261.84 (\$3,001.73), Custodial/Section 125 Account \$11,431.44 (\$11,056.45). Total assets were \$3,285,687.65 compared to \$2,375,863.87 a month ago, and \$4,240,103.89 a year ago. May receipts totaled \$1,133,357.05. That compares to \$304,830.38 in April. Disbursements totaled \$464,662.07 including \$144,966.94 for claims and \$319,695.13 for payroll. Building Fund receipts totaled \$183,612.75. Building Fund expenditures were \$20,000.00. Claims to the General Fund totaled \$52,289.09. Rasmussen moved, Sauser seconded, to approve the consent items. Upon roll call vote, the ayes were unanimous. Motion carried.
