

**Plainview Public Schools Board of Education Meeting  
Monday, January 13, 2020**

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 7:00 p.m. by Mike Sauser, President, on Monday, January 13, 2020. Frahm moved, Tarr seconded to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Sauser, Krista Hanks, Tim Rasmussen, Wyatt Frahm, Jim Thor and Trenton Tarr.

Hanks moved, Frahm seconded to elect Mike Sauser as President of the Board. Upon roll call vote, the ayes were unanimous. Motion carried. Thor moved, Tarr seconded to elect Wyatt Frahm as Vice President of the Board. Upon roll call vote, the ayes were unanimous. Motion carried. Tarr moved, Thor seconded to elect Krista Hanks as Board Secretary. Upon roll call vote, the ayes were unanimous. Motion carried.

**CONSENT ITEMS**

Consent items included the minutes of the December 9, 2019 regular meeting, the financial reports, and the January claims. The financial report (with last month's figures in parentheses) showed a balance of \$190,605.54 (\$569,917.06) in the General Fund. CDs total \$1,000,000.00 (1,000,000.00), Special Building Fund \$782,033.92 (\$787,610.03), Petty Cash \$612.26 (\$2,496.85), Activity Account \$129,839.09 (\$133,548.87), Lunch Account \$19,838.44 (\$20,589.10), Employee Benefit Fund \$52,024.16 (\$51,976.54), Depreciation Fund \$113,159.05 (\$113,046.07), Payroll Account \$2,982.24 (\$2,681.43), Custodial/Section 125 Account \$17,868.49 (\$21,344.39). Total assets were \$2,225,344.94 compared to \$2,575,827.16 a month ago, and \$2,420,931.06 a year ago. December receipts totaled \$86,702.93. That compares to \$57,538.36 in November. Disbursements totaled \$466,014.45 including \$127,383.18 for claims and \$338,631.27 for payroll. Building Fund receipts totaled \$3,546.39. Building Fund expenditures were \$9,122.50. Claims to the General Fund totaled \$83,618.25. Hanks moved, Rasmussen seconded, to approve the consent items and move agenda item #11 to the end of the meeting. Upon roll call vote, the ayes were unanimous. Motion carried.

**APPROVAL OF DR. DARRON ARLT AS THE DISTRICT'S NON-DISCRIMINATION COMPLIANCE COORDINATOR**

Hanks moved, Frahm seconded to approve Dr. Darron Arlt as the district's Non-discrimination Compliance Coordinator. Upon roll call vote, the ayes were unanimous. Motion carried.

**ACTION ON ACCEPTING RESIGNATION OF ANDREA MILLER AT THE END OF THE SCHOOL YEAR**

Rasmussen moved, Hanks seconded to approve the resignation of Andrea Miller at the end of the contract year. Upon roll call vote, the ayes were unanimous. Motion carried.

**ACTION ON ACCEPTING THE PROPOSAL FOR 19 NEW WIRELESS ACCESS POINTS FOR THE ELEMENTARY**

Frahm moved, Sauser seconded to accept the proposal for 19 new wireless access points for the elementary in the amount of \$5,869.48. Upon roll call vote, the ayes were unanimous. Motion carried.

The Board intends to take action in February on the following contract terms for Dr. Darron Arlt:

- 2.5% Salary increase to \$133,350
- \$1,000/yr. for cell phone allowance
- \$40/day buy back each year for unused Sick Days over 50
- \$45/day buy back for unused Sick Days @ retirement if over 50 in bank
- Early Retirement Incentive:
  - Minimum 10 years' service
  - At least 55 years of age
  - \$7,000/yr. for 5 years or until social security age
