# Plainview Public Schools Board of Education Meeting Monday, August 10, 2020

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 7:00 p.m. by Mike Sauser, President, on Monday, August 10, 2020. Frahm moved, Tarr seconded to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Sauser, Krista Hanks, Tim Rasmussen, Jim Thor, Wyatt Frahm and Trenton Tarr.

Hanks moved, Rasmussen seconded to move the President's report to the end of the agenda. Upon roll call vote, the ayes were unanimous. Motion carried.

## **CONSENT ITEMS**

Consent items included the minutes of the July 13, 2020 regular meeting, the financial reports, and the August claims. The financial report (with last month's figures in parentheses) showed a balance of \$733,707.87 (\$1,082,321.70) in the General Fund. CDs total \$1,000,000.00 (1,000,000.00), Special Building Fund \$562,694.20 (\$685,931.00), Petty Cash \$2,501.82 (\$2,501.71), Activity Account \$110,815.84 (\$102,080.49), Lunch Account \$39,480.70 (\$42,273.51), Employee Benefit Fund \$52,172.03 (\$52,163.17) Depreciation Fund \$113,524.49 (\$113,500.39), Payroll Account \$2,970.51 (\$3,732.53), Custodial/Section 125 Account \$12,427.35 (\$13,339.45). Total assets were \$2,536,062.07 compared to \$3,007,166.85 a month ago, and \$2,698,442.95 a year ago. July receipts totaled \$59,095.78. That compares to \$389,200.18 in June. Disbursements totaled \$407,709.61 including \$90,677.10 for claims and \$317,032.51 for payroll. Building Fund receipts totaled \$5,541.20. Building Fund expenditures were \$128,778.00. Claims to the General Fund totaled \$94,232.74. Hanks moved, Tarr seconded, to approve the consent items. Upon roll call vote, the ayes were unanimous. Motion carried.
