Plainview Public Schools Board of Education Meeting Monday, December 14, 2020

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 7:00 p.m. By Mike Sauser, president. Frahm moved, Tarr seconded, to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Sauser, Tim Rasmussen, Jim Thor, Wyatt Frahm, Trenton Tarr and Krista Hanks.

CONSENT ITEMS

Consent items included the minutes of the November 9, 2020 regular meeting, the financial reports, and the December claims. The financial report (with last month's figures in parentheses) showed a balance of \$467,722.56 (\$849,946.09) in the General Fund. CDs total \$1,000,000.00 (1,000,000.00), Special Building Fund \$620,804.81 (\$617,554.22), Petty Cash \$2,456.04 (\$2,500.18), Activity Account \$134,959.27 (\$108,378.57), Lunch Account \$1,621.66 (\$27,507.28), Employee Benefit Fund \$52,206.92 (\$52,198.05), Depreciation Fund \$113,619.38 (\$113,595.26), Payroll Account \$4,201.33 (\$3,860.65), Custodial/Section 125 Account \$15,926.45 (\$19,122.67). Total assets were \$2,289,178.48 compared to \$2,719,412.70 a month ago, and \$2,575,827.16 a year ago. November receipts totaled \$60,698.86. That compares to \$201,478.50 in October. Disbursements totaled \$442,922.39 including \$75,250.27 for claims, \$367,672.12 for payroll. Building Fund receipts totaled \$3,250.59. There were no Building Fund expenditures. Lunch fund claims totaled \$12,547.21. Claims to the General Fund totaled \$124,339.95. Tarr moved, Frahm seconded, to approve the consent items and a \$20,000.00 transfer from general to lunch fund to be reimbursed when the federal lunch funds are received. Upon roll call vote, the ayes were unanimous. Motion carried.

Dr. Arlt provided each Board member with a manual on Fundamentals of Board Service. Deb Jensen and Chance Anderson were present to discuss webinars they attended in regards to board service.

Tarr moved, Rasmussen seconded to adopt policy #402.15-Staff Conduct with Students. Upon roll call vote, the ayes were unanimous. Motion carried.
