Plainview Public Schools Board of Education Meeting Monday, October 11, 2021

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 7:00 p.m. by Mike Sauser, president. Frahm moved, Anderson seconded, to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Sauser, Tim Rasmussen, Jim Thor, Wyatt Frahm, Deb Jensen and Chance Anderson. Rasmussen moved, Frahm seconded to approve the agenda. Upon role call vote, the ayes were unanimous.

CONSENT ITEMS

Consent items included the minutes of the September 13, 2021 regular meeting, the financial reports, and the October claims. The financial report (with last month's figures in parentheses) showed a balance of \$585,799.86 (\$69,790.45) in the General Fund. CDs total \$1,000,000.00 (1,000,000.00), Special Building Fund \$262,196.95 (\$200,685.38), Petty Cash \$2,484.93 (\$801.24), Activity Account \$77,222.54 (\$86,435.75), Lunch Account \$29,923.78 (\$53,199.56), Employee Benefit Fund \$52,283.85 (\$52,277.40), Depreciation Fund \$113,834.19 (\$113,815.48), Payroll Account \$3,149.98 (\$2,731.61), Custodial/Section 125 Account \$20,416.06 (\$6,494.19). Total assets were \$2,065,911.74 compared to \$1,467,868.24 a month ago, and \$2,939,835.18 a year ago. September receipts totaled \$1,007,323.65 compared to \$41,422.98 in August. Disbursements totaled \$491,314.24 including \$118,362.82 for claims, and \$372,951.42 for payroll. Building Fund receipts totaled \$161,361.57. Building Fund claims were \$99,850.00. Claims to the General Fund totaled \$81,400.40. Frahm moved, Jensen seconded, to approve the consent items. Upon roll call vote, the ayes were unanimous. Motion carried.
