Plainview Public Schools Board of Education Meeting Monday, December 13, 2021

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 5:31 p.m. by Mike Sauser, president. Frahm moved, Anderson seconded, to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Sauser, Tim Rasmussen, Wyatt Frahm, Deb Jensen and Chance Anderson. Dr. Thor arrived at 5:41 p.m. Item #10, School Nutrition was moved to after item #12. Frahm moved, Jensen seconded to approve the agenda. Upon role call vote, the ayes were unanimous.

CONSENT ITEMS

Consent items included the minutes of the November 8, 2021 regular meeting, the financial reports, and the December claims. The financial report (with last month's figures in parentheses) showed a balance of \$45,890.82 (\$414,184.52) in the General Fund. CDs total \$1,000,000.00 (1,000,000.00), Special Building Fund \$262,862.25 (\$278,493.00), Petty Cash \$2,441.69 (\$2,483.79), Activity Account \$101,916.81 (\$59,573.04), Lunch Account \$45,337.55 (\$44,409.19), Employee Benefit Fund \$52,296.96 (\$52,290.08), Depreciation Fund \$113,872.24 (\$113,852.28), Payroll Account \$3,724.76 (\$3,193.13), Custodial/Section 125 Account \$19,554.53 (\$19,205.00). Total assets were \$1,445,462.49 compared to \$1,907,277.35 a month ago, and \$2,289,178.48 a year ago. November receipts totaled \$92,363.16 compared to \$290,272.44 in October. Disbursements totaled \$460,656.86 including \$80,406.68 for claims, and \$380,250.18 for payroll. Building Fund receipts totaled \$2,163.25. Building Fund claims were \$17,794.00. Claims to the General Fund totaled \$202,435.12. Frahm moved, Rasmussen seconded, to approve the consent items. Upon roll call vote, the ayes were unanimous. Motion carried.

Frahm moved, Jensen seconded to approve the borrowing of \$800,000.00 from Midwest Bank at a rate of 1.75% over 3 years With Dr. Arlt authorized to sign the note. First payment is due June 2022. Upon roll call vote, the ayes were unanimous. Motion carried.

ACTION ON APPROVING RESIGNATION OF ROBIN REED AT THE END OF THE 2021-2022 SCHOOL YEAR

Jensen moved, Anderson seconded to approve the resignation of Robin Reed effective at the end of the 2021-2022 school year. Upon roll call vote, the ayes were unanimous. Motion carried.

ACTION ON APPROVING RESIGNATION OF MARY ABBENHAUS AT THE END OF THE 2021-2022 SCHOOL YEAR

Anderson moved, Frahm seconded to approve the resignation of Mary Abbenhaus effective at the end of the 2021-2022 school year. Upon roll call vote, the ayes were unanimous. Motion carried.

ACTION ON APPROVING RESIGNATION OF TERRI HASELHORST AT THE END OF THE 2021-2022 SCHOOL YEAR
