Plainview Public Schools Board of Education Meeting Monday, April 11, 2022

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 7:00 p.m. by Mike Sauser, president. Frahm moved, Rasmussen seconded, to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Sauser, Tim Rasmussen, Deb Jensen, Jim Thor, Wyatt Frahm and Chance Anderson.

Jensen moved, Thor seconded to approve the agenda with a change to remove item #10-Review Board Policies. Upon roll call vote, the ayes were unanimous. Motion carried.

CONSENT ITEMS

Consent items included the minutes of the March 14, 2022 regular meeting, the financial reports, and the April claims. The financial report (with last month's figures in parentheses) showed a balance of \$385,688.42 (\$581,105.87) in the General Fund. CDs total \$1,000,000.00 (1,000,000.00), Special Building Fund \$498,912.22 (\$625,725.22), Petty Cash \$2,599.42 (\$2,229.32), Activity Account \$73,079.32 (\$73,978.28), Lunch Account \$58,445.78 (\$51,429.78), Employee Benefit Fund \$52,323.25 (\$52,316.30), Depreciation Fund \$113,948.39 (\$113,928.41), Payroll Account \$5,369.84 (\$4,957.11), Custodial/Section 125 Account \$13,619.72 (\$18,374.40). Total assets were \$2,164,826.41 compared to \$2,440,235.91 a month ago, and \$2,135,962.83 a year ago. March receipts totaled \$252,543.33 compared to \$433,530.18 in February. Disbursements totaled \$447,960.78 including \$83,808.78 for claims, and \$364,152.00 for payroll. Building Fund receipts totaled \$23,187.00. Building Fund claims were \$150,000.00. Claims to the General Fund totaled \$39,159.91. Frahm moved, Anderson seconded, to approve the consent items. Upon roll call vote, the ayes were unanimous. Motion carried.
