### **RECAP OF PROCESS TO DATE**

Bob Soukup from CWP architects brought the committee back up to speed on major steps to get us to this point. He introduced our CM (Construction Manager) from Hausmann Construction, Steve Thiele, who is now on board as a team member. Also, in attendance from Hausmann were Jeff Bernecker, Marc Munford, and John Wieser. Bob also recognized Tobin Buchanan and Jeff Sneider from Northland Securities who will be our Municipal Advisor. We now have all the right pieces in place to move more quickly to a clearer vision for scope and cost of any proposed project.

### **REVIEW OF SURVEY INFORMATION**

Bob shared details of the survey that was distributed to committee members and to the teaching staff. Priority items as well as bubble items and those not perceived as important to respondents was shared. Attendees discussed the logic in distributing the survey publicly. The basic consensus was that an anonymous survey widely distributed for anyone to complete would not provide data that could be representative of the informed taxpayer in the district. We will make the survey available to attendees at Parent-Teacher Conferences on Thursday, September 25<sup>th</sup>.

#### **MOVING FORWARD**

The committee began sharing some reflections on the survey results as well as discussing possible timelines. The plan is to move forward at a pace to be ready for a February mail-in vote but if the committee and board feel more time is necessary, a question on the May primary ballot is also reasonable.
