Plainview Public Schools Board of Education Meetings Monday, November 10, 2025

The regular monthly meeting of the Board of Education of District 5 of Plainview, NE, was called to order at 6:00 p.m. by Tim Rasmussen, President, on Monday, November 10, 2025. Anderson moved, Alexander seconded to declare an open meeting. Upon roll call vote, the ayes were unanimous. Motion carried. The rules for open meetings were posted at the back of the room. Roll call was answered by Rasmussen, Wyatt Frahm, Caden Alexander, Justin D. Doerr, Melissa Doerr and Chance Anderson.

Anderson moved, Frahm seconded to approve the agenda. Upon roll call vote, the ayes were unanimous. Motion carried.

CONSENT ITEMS

Consent items included the minutes of the October 13, 2025 regular meeting, the October 20 and November 3, 2025 special meetings, the financial reports, and the November claims. The financial report (with last month's figures in parentheses) showed a balance of \$1,493,538.34 (\$1,959,494.68) in the General Fund, CDs total \$1,000,000.00 (\$1,000,000.00), Special Building Fund \$285,962.13 (\$25,362.04), Petty Cash \$2,500.22 (\$2,480.11), Activity Account \$15,756.43 (\$30,158.99), Nutrition Account \$20,533.00 (\$18,704.38), Employee Benefit Fund \$54,880.58 (\$54,815.87), Depreciation Fund \$74,994.23 (\$74,905.80), Payroll Account \$95,515.43 (\$109,543.93), Custodial/Section 125 Account \$19,598.23 (\$18,416.67). Total assets were \$2,982,265.85 compared to \$3,148,093.38 a month ago, and \$2,253,029.89 a year ago. October receipts totaled \$363,162.74 compared to \$788,828.21 in September. Disbursements totaled \$829,119.08 including \$151,049.09 for claims, \$250,000.00 transfer to building fund, \$428,090.00 for payroll and \$(20.01) for a void check. Building Fund receipts totaled \$260,600.09. There were no building fund expenditures. Claims to the General Fund totaled \$81,012.74. Anderson moved, Justin D. Doerr seconded, to approve the consent items. Upon roll call vote, the ayes were unanimous. Motion carried 6-0.
